We have some important developments to share with you.

News on NARA reopening

Like all of you, we absorbed the latest news of a possible COVID vaccine with much optimism, but without more concrete information we are planning based on the best data currently available. ARA representatives are now meeting weekly with NARA executives to discuss the progress being made toward the reopening of NARA's research faculties. At this time nine NARA facilities, including St Louis have reverted to 'closed' status due to the recent surge in COVID-19 cases. This means that once the virus infection numbers begin to subside NARA will be starting over with phase I. Each phase will take a minimum of two weeks to complete. The best-case scenario is a limited reopening in January or February and more closures are certain to occur in the coming days.

Once phase III is completed, a limited return of public patrons will be allowed at some research locations. We expect Archives II will open first. Finding aids at Archives II are being digitized and will be available on the NARA catalog. In theory, you will request records ahead of time, set an appointment and when you arrive your records will be waiting for you. There will be no ordering of records while on-site. Masks will be mandatory, space will be limited, and appointment blocks will likely be for a maximum of four to five hours per day. Researchers will wipe down stations before and after conducting research. Public access PCs and photocopiers are currently slated for removal from the research rooms.

NARA has indicated that they believe that many of the new, safety-related

restrictions to access due to COVID-19 will become permanent. It is the view of the ARA that while temporary changes for safety reasons are to be expected, restrictions to access should not be permanent. In fact, we are hopeful that our efforts to increase funding for NARA will result in expanded access in the coming years.

We will continue to keep our members updated on our discussions with NARA on the reopening.

Recent addition to the ARA board of officers

We are pleased to welcome Bill Beigel as our newest addition to the ARA board! Mr. Beigel is an American military records researcher, speaker, and author specializing in service histories of American veterans and casualties of World War II. Since 1999, Mr. Beigel has researched thousands of WWII veterans and casualties for individuals, families, private and public organizations worldwide. He is the author of "Buried on the Battlefield – Not My Boy: The Return of the Dead from World War Two," which has been optioned for a documentary film. He is building the world's first complete online database of the 407,000 American military casualties from World War II, which presently includes more than 100,000 names.

First Town Hall Meeting Held

On October 19th, we held our first Town Hall Meeting with approximately 40 members joining on Zoom.

Don Mounts served as moderator and introduced the board members and explained that this meeting was to allow transparency and give researchers a voice through our association.

At the time of the town hall, our membership stood at 86 members: 44 individuals (including self-employed researchers), 13 research companies, 23 non-profits, and 3 corporations/major sponsors who have pledged \$1000 or more annually. Our exhibition at the National Organization for Veterans' Advocates fall conference examined how veteran advocates can obtain proof required to secure PTSD benefits for their clients.
